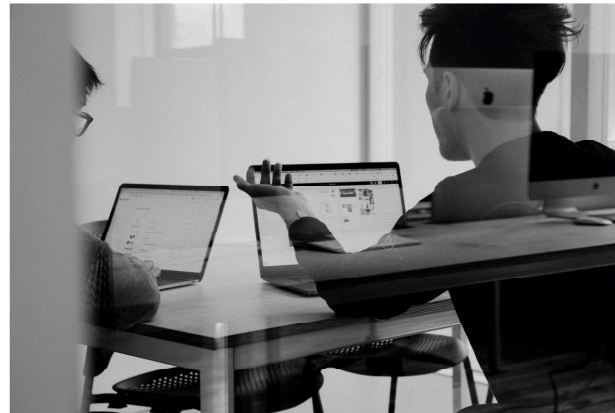
Our graduate and school leaver programmes...
